## Section 4 - First Aid Measures

### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

Eyebaths or eyewash stations and safety deluge showers should be provided where this product is being used.

**Inhalation:** No first aid measures normally required. However, if vapours or mists have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more than about 30 minutes, seek medical advice.

**Skin Contact:** If product gets on skin, wash skin with soap and water. No further measures should normally be required.

**Eye Contact:** Flush the contaminated eye(s) with lukewarm, gently flowing water until the product is removed or until irritation has ceased, while holding the eyelid(s) open. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

**Ingestion:** If swallowed, do NOT induce vomiting. Give a glass of water.

## Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. However, this product may form flammable or explosive dust clouds in air.

## Section 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. If there is a significant chance that dusts are likely to build up in the cleanup area, we recommend that you use a respirator. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Recycle containers wherever possible after careful cleaning. After spills, wash area, preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. A TWA has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level.
