Potential Health Effects

This product is virtually non-toxic by normal routes of exposure. There is no data to suggest that chronic exposure has any adverse health effects in the way of carcinogenicity, mutagenicity or reproductive effects. This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. Section 4 - First Aid Measures

After spills, wash area, preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services.
