Emergency Overview

Physical Description & colour: Brown crumbles with red and white flecks.

Odour: Mild organic odour

Major Health Hazards: This product is virtually non-toxic by normal routes of exposure. There is no data to suggest that chronic exposure has any adverse health effects in the way of carcinogenicity, mutagenicity or reproductive effects. However, as with many products of organic origin, it is possible that this product may contain pathogenic micro-organisms

Potential Health Effects

Inhalation: Data indicates that this product may be irritating if inhaled. May lead to minor discomfort which should quickly disappear once exposure has ceased.

Skin Contact: Data suggests that this product should present no significant problems to typical persons if used as intended.

Eye Contact: This product is mildly irritating to the eyes. It is likely to cause mild discomfort such as watering and redness of the eyes, however this should quickly disappear once exposure is over

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. Section 4 - First Aid Measures

General Information:

Eyebaths or eyewash stations should be provided where this product is being used.

Inhalation: No first aid measures normally required. However, if vapours or mists have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more than about 30 minutes, seek medical advice.

Skin Contact: If product gets on skin, wash skin with soap and water. No further measures should normally be required.

Eye Contact: Flush the contaminated eye(s) with lukewarm, gently flowing water until the product is removed or until irritation has ceased, while holding the eyelid(s) open. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Ingestion: If swallowed, do NOT induce vomiting. Give a glass of water.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

No hazardous decomposition products are expected at temperatures normally achieved in a fire. Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water.

Extinguishing Media: Not Combustible. Use extinguishing media suited to burning materials.

Fire Fighting: If a significant quantity of this product is involved in a fire, call the fire brigade.

Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. If there is a significant chance that dusts are likely to build up in the cleanup area, we recommend that you use a respirator. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Recycle containers wherever possible after careful cleaning. After spills, wash area, preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this MSDS and the label, instructions on the label prevail. Dispose of only in accord with all regulations.

Section 7 - Handling and Storage

Handling: Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

Storage: Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight. Make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Check packaging - there may be further storage instructions on the label.

No exposure limits have been set for any of the ingredients of this product

The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The exposure value at the TWA is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. A TWA has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, Dec 2003.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.
