## Section 4 - First Aid Measures

## Section 6 - Accidental Release Measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. **Section 12 - Ecological Information**

**Effects on Birds:** Imidacloprid is toxic to some game birds. The LD<sub>50</sub> is 152 mg/kg for bobwhite quail, and 31 mg/kg in Japanese quail. However Imidacloprid is present in this product at such low concentrations that is unlikely to cause harm.

**Effects on Aquatic Organisms:** The toxicity of Imidacloprid to fish is moderately low. The 96-hour LC<sub>50</sub> of Imidacloprid is 211 -280mg/l for a range of species. In tests with Daphnia, the 48-hour EC<sub>50</sub> was 85 mg/L. Products containing Imidacloprid may be very toxic to aquatic invertebrates. However Imidacloprid is present in this product at such low concentrations that is unlikely to cause harm.
