Section 12 - Ecological Information

Effects on Birds: Imidacloprid is toxic to some game birds. The LD₅₀ is 152 mg/kg for bobwhite quail, and 31 mg/kg in Japanese quail. However Imidacloprid is present in this product at such low concentrations that is unlikely to cause harm.

Effects on Aquatic Organisms: The toxicity of Imidacloprid to fish is moderately low. The 96-hour LC₅₀ of Imidacloprid is 211 -280mg/l for a range of species. In tests with Daphnia, the 48-hour EC₅₀ was 85 mg/L. Products containing Imidacloprid may be very toxic to aquatic invertebrates. However Imidacloprid is present in this product at such low concentrations that is unlikely to cause harm.
