This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight. If stacking is necessary, bulk bags should be stored in a stable manner, preferably in a pyramidal style. The pallet Capacity Rating (Design Weight) should not be exceeded on the bottom tier for other packs. High stacking should be avoided as pressure promotes caking. Store away from farm chemicals e.g. insecticides, fungicides and herbicides. This product when stored in a confined, unventilated space can give off ammonia or other odour and lead to the depletion of oxygen within this space and other confined areas.
