## Section 4 - First Aid Measures

## Section 6 - Accidental Release Measures

Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

**Handling:** Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

**Storage:** Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Ensure containers are labelled, protected from physical damage and sealed when not in use. Keep from extreme heat and open flames and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Bagged fertilisers should be stored under cover and out of direct sunlight

## Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions.

**Conditions to Avoid:** Heat, flames.

## Section 11 - Toxicological Information

**Inhalation:** Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort. No data for health effects associated with long term inhalation.

**Environment:** Avoid contamination of waterways. Fertilisers, particularly those containing nitrogen and phosphorus can stimulate weed and algal growth in static surface waters. Nitrogen fertilisers can also contain or form Nitrate which can contaminate surface and ground water. High nitrate concentrations may render the water unsuitable for human and livestock consumption.

**Ecotoxicity effects:** Dissolves slowly in water. Harmful to aquatic life

**Persistence/degradation:** Will persist for weeks in soil, but is a plant nutrient.

## Section 13 - Disposal Considerations

**Disposal:** There are many pieces of legislation covering waste disposal and they differ in each state and territory, so each user must refer to laws operating in their area.
