Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight. If stacking is necessary, bulk bags should be stored in a stable manner, preferably in a pyramidal style. Store away from farm chemicals e.g. insecticides, fungicides and herbicides. This product when stored in a confined, unventilated space can give off ammonia or other odour and lead to the depletion of oxygen within this space and other confined areas.
