Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. pyramidal style. Store away from farm chemicals e.g. insecticides, fungicides and herbicides. This product when stored in a confined, unventilated space can give off ammonia or other odour and lead to the depletion of oxygen within this space and other confined areas.
