External surrounds of buildings and structures including: gardens, ant nests and trails	Nuisance Ants	7.5g – 15g per square metre	Apply to areas where ants are active. Sprinkle evenly over the area to be treated. Where possible, apply directly on and around ant nests or trails. Reapply as necessary. Use higher rate for heavy infestations and for maximum residual control. Use the lower rate for maintenance situations or to control light infestations. When applied to pavers, sweep excess product into cracks for best control

When used as directed, Amgrow Patrol Fixant Advanced Ant Sand will not harm soil and plants. Inconspicuous in use – ideal for pavers and paths. Can be used on gardens or hard surfaces.

**CAUTION:** For outdoor use only. DO NOT spread granules directly onto humans, pets, exposed food, food preparation areas or food utensils.

Very toxic to aquatic life.

DO NOT contaminate wetlands or watercourses with this product or used containers.

Before treatment, remove animals and pets from the areas to be treated. Cover or remove any open food and water containers. Keep away from domestic pets, especially dogs. If dogs eat the granules, contact your veterinary surgeon immediately. Use with caution around pets — ensure product is well dispersed i.e. swept in between pavers, cracks and crevices and dispersed into soil. Cover or remove fishponds, aquariums etc before application. DO NOT apply within 2 metres of a fishpond or water containing fish or aquatic species.

**STORAGE AND DISPOSAL:** Store in the closed, original container in a cool, dry place out of the reach of children. Do not store in direct sunlight. Dispose of empty container by wrapping in paper, placing in plastic bag and putting in garbage.
