## Section 4 - First Aid Measures

### General Information:

**Skin Contact:** Gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed.

**Eye Contact:** If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 15 minutes or until the product is removed. ## Section 5 - Fire Fighting Measures

## Section 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. **Storage:** Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Store away from farm chemicals e.g. insecticides, fungicides and herbicides.
