

DIRECTIONS FOR USE: Shake can well before use. Amgrow Patrol Wasp and Spider Destroyer, when used according to directions, will give effective residual control of insect and other pests listed below in situations such as domestic, public service, industrial and commercial areas. Apply as a barrier spray around inaccessible places.

PEST	STATE	CRITICAL COMMENTS
Spiders	All States	Spray around and in garbage bins, food disposal areas, sills and other points of entry.
European wasps		Spray eaves, webs and other sites where spiders lurk.
		Use for accessible nests. Spray after dark and wear insect proof clothing to avoid being stung. Spray in and around nest entrances until the nest is saturated. Spray again 3 days later then destroy the nest.
