Section 4 - First Aid Measures

Section 6 - Accidental Release Measures

Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

Section 7 - Handling and Storage

Handling: Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

Storage: Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs. Keep from extreme heat and open flames and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Section 11 - Toxicological Information

Section 12 - Ecological Information

Environment: Avoid contamination of waterways. Fertilisers, particularly those containing nitrogen and phosphorus can stimulate weed and algal growth in static surface waters. Nitrogen fertilisers can also can also contain or form Nitrate which can contaminate surface and ground water. High nitrate concentrations may render the water unsuitable for human and livestock consumption.

Ecotoxicity effects: Dissolves slowly in water. Harmful to aquatic life

Persistence/degradation: Will persist for weeks in soil, but is a plant nutrient.

Section 13 - Disposal Considerations

Disposal: There are many pieces of legislation covering waste disposal and they differ in each state and territory, so each user must refer to laws operating in their area. In some areas, certain wastes must be tracked.
